3. User Protection Responsibilities

If you are redistributing or installing Signal Enhance Devices for end users (e.g., clients, customers, or employees), you

are responsible for upholding our privacy standards on their behalf.

This includes:

- Not injecting telemetry or ad systems into the firmware

- Not collecting or selling personal user data without their consent

- Ensuring users are clearly informed of who manages their data

Signal Enhance Devices do not collect or transmit personal data by default - and we will never enable advertising, tracking, or data monetization from the platform.

4. PII & Entity Data Collection

Due to the nature of business relationships, we will collect personally identifiable information (PII) from Entity representatives for:

Retention Policy:
